

## **Class Syllabus: Competition Mock Trial**

**Course description**: Trial Advocacy Competition is a selective course (students must try out and be accepted onto a team.) Two teams will be selected to actively compete in the Law Foundation's regional, state, and potentially national competitions. Team C is a Freshman/Sophomore team that will scrimmage with our own teams, and compete in the regional competitions (The C team is not qualified for Idaho State competition or Nationals). Team C will form based on interest and try-out scoring. We may not create a team C if there is insufficient interest.

Students are selected for the A & B teams by the first practice in December based upon 1) Past performance, 2) Demonstrated commitment and teachability, 3) Performance in tryouts, if required. 4) Teams are fit to create the right combination of talent. Team B&C students are selected based upon TA 101 performance and tryouts.

### **Selection Process**

- Tryouts will be held on November 8<sup>th</sup>, through the 20th (5<sup>th</sup> hour) and 16<sup>th</sup> from 3-6.
- Competition members will be selected by December 2nd after case release
- Case release is scheduled for November 20th
- Students may drop the class without a "w" or penalty until December 2nd. Students are responsible to initiate and process the drop paperwork.
- A/B/C Team assignments will be made by December 15<sup>th</sup>
- Role assignments will be made by January 4<sup>th</sup>
- Draft documents due by January 4th
- Final documents will be complete by January 24th

#### **Expectations & Information**

- Any written assignments are to be turned in typed, based upon the school's standard formatting, and printed on paper (not electronic), unless otherwise specified. The school will not print electronic copies for you. In emergencies, the school will charge for printing.
- Students must have a Gmail account so that they can access Google Docs for cooperative work with other students.
- Makeups for absences are the responsibility of the student. You are responsible to check with the teacher (RenWeb may not reflect recent changes) for specific work assignments and due dates when you are absent or planning to be absent. Missing work can easily result in a failing grade for the quarter or semester because there are fewer grades than in other classes (since we meet only twice per week).
- Assignments will be made based upon the best overall team strategy, not necessarily on the best performance of individuals during the audition.
- Students who are unable or unwilling to commit to the dates within this syllabus may wish to drop the class by the drop/add date. Students may not drop after this date.
- Mock Trial is a 2 credit Applied Art. You must complete the full course (November through March) to receive credit.

• No electronic devices (outside of google docs) or texting during practice unless it is an emergency or to arrange scheduling with family for pick-up/ drop-off times.
